- Guidelines for Painting Competition 2012-13

## School, State & National Level Painting Competition on Water Conservation - 2012 - 13 for School Children of 4th, 5th & 6th standards

The Ministry of Water Resources has decided to conduct the third nationwide painting competition in order to spread awareness on water conservation. The Ministry is organizing painting competition at school level, state level and national level as one of the activity of the campaign. The painting competition would make the children aware about need of conserving this precious resource and at the same time would involve their parents in the above noble cause.

It has been decided to hold the competition for 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> standard students in three stages, namely, School, State and National Level. The State level winners and National level winners will be awarded cash prizes.


## School Level Competition

- 1. The school level competition 2012 for the students of 4th, 5th, and 6th standards is being launched in all the States/UT's from August October 2012
- 2. School Principals may be requested to organize painting competition of 2 hour duration at their schools.
- Drawing materials for the school level would be provided by the schools/ students and no cost in this regard would be borne by the MoWR/CGWB/ CGWA.
- 4. Painting may be made preferably on A4 size paper, though there will be no restriction on type/size of paper, paints, crayons, water colour, etc.
- 5. The theme for the painting competition are as follows:
  - a. School level Painting Competition:
    - i. Water and Climate Change
    - ii. Save water from Pollution
    - iii. Water security Food Security
- 6. All paintings must contain the following details at the back of the drawing sheet—Name of student, class, Section, School, full school address, father/mothers name, telephone number of school and parents, signature of Principal.
- 7. Paintings not signed by the school Principal or sent directly by student/parent to the Nodal Officer will not be accepted.
- 8. The Regional Director/ Officer in charge/ HOO of the Regional Offices of CGWB would be the Nodal Officers for the painting competition for the State/UT's under their jurisdiction.

- Three best paintings are to be selected from rach school and the same are to be forwarded to the concerned Nodal Officer of CGWB. The selections of the three best paintings from each school are to be done by the respective school authorities.
- 10. All participants of school level competition will be given a participation certificate signed by Regional Director, CGWB and Member Secretary, CGWA.
- 11.List of participants to be obtained for each school by the Regional Offices including class & school with school address and record maintained.
- 12. All efforts to be made by the Regional Offices of CGWB to exceed the given targets for the painting competition.
- 13. The competition is to be conducted within the respective State/UT under the jurisdiction of Regional Director.

## State Level Painting competition


- 1. The State Level Painting competition is to be conducted on 21.11.12
- The best 50 paintings is to be selected by a board of juries comprising five members including Regional Director from amongst the entries received from the schools.
- The state level competition is to be conducted with 50 students whose paintings
  are selected as best 50paintings from amongst the entries of the school level
  painting competition.
- 4. Theme for the State Level Painting Competition will be disclosed at the venue.
- Jury to comprise of renowned persons in Art, drawing teachers, officials from state government education department, etc., and Regional Director CGWB.
- Venue of the competition would be arranged and by the Regional Office of CGWB.
- Observer from the MoWR and CGWA/CGWB Delhi/ Faridabad is likely to be present during the state level competition.
- Participants, alongwith two parents/guardians for the state level competition would be paid to and fro fare by ordinary bus/sleeper class rail fare/ from the place of residence to competition venue.
- An incidental charge of Rs. 1000/- would be paid to each of the 50 participants for attending the State level competition.
- 10. All drawing materials and associated requirements would be provided by CGWB. Items may include a kit containing paints, ruler, brushes, pencils, erasers, etc.
- 11. Drawing sheets for the painting will be provided by the Regional Offices. The sheets would be of 380 mm x 510 mm size (approx. 15" x 20").
- 12. Students are allowed to use their own painting materials if preferred.
- 13.All 50 students must submit two latest passport size coloured photographs, preferably alongwith soft copy.



- 14. All students should bring identity proof or letter from respective school Principal.
- 15. Selection of the 1st, 2nd & 3rd prizes and 10 consolation prizes are to be completed on the same day by juries and winners awarded.
- 16. The Chief Guest of the function would give aw 1/2 the prizes to winning students.
- 17. The cash prize award is Rs. 10,000/- for First Prize, Rs. 8000/- for Second Prize and Rs. 5000/- for Third Prize, Ten Consolation Prizes (@ Rs. 1000/-) would also be awarded.
- 18. Winners to be awarded certificate of merit.
- 19.All state level participants to be given participation certificate for the state level competition.
- 20. Arrangements for lunch, tea etc., have to be made for the day of the competition by the Regional Office.
- 21. Participation & Merit certificates for State level competition to be got printed by concerned Regional Offices as per requirement.
- 22. Suitable Chief Guest for State level function may be invited.
- 23.1st, 2nd & 3rd prize winners to be informed about the national competition to be held at Delhi.
- 24. Photographs (digital) of all 50 participants should be taken individually along with respective paintings.
- 25. Group photograph (digital) of participants should also be taken.
- 26. Good coverage through video and still photography to be made.
- 27. All expenditure to be incurred strictly following the provisions of GFR's.
- 28. First, second and third winners details to be send to Delhi for preparing the list of participants for the National Competition.
- 29. Regional Directors may ensure a detail coverage in press and electronic media.

## NATIONAL LEVEL PAINTING COMPETITION

- 1. The National Level Competition is to be conducted on 21.1.2013 at New Delhi.
- 2. The winners of first, second and third prizes from each of the States/UT's (i.e. three from each State/UT) would be called to New Delhi for the competition.
- Tentative venue of the competition would bε at ICAR, PUSA, New Delhi. Total participants 90.
- 4. The National Competition would have one first prize (Rs. 1,00,000), four second prizes (@ Rs. 50,000), eight third prizes (@ Rs 25,000). All other participants (remaining 74 students) would be given consolation prizes (@ Rs. 5,000).
- 5. All students would be paid to and fro rail fare by AC III Tier/Bus, alongwith two accompanying parents/guardians on production of proof of journey undertaken in the entitled class. Participants from A&N Islands would be reimbursed economy class air fare from Port Blair to Delhi and back on production of proof of journey



- undertaken by them and as per actuals. The reimbursement would be made for participant and accompanying two parents/ guardians on production of proof of journey undertaken by the entitled class.
- Arrangements for stay (food and lodging) at Delhi will be made by the participantsthemsleves. A lump sum amount of Rs. 3000/- would be paid to each participant of the National competition for food, lodging, transport and incidental charges.
- Students with their parents/ guardians would report at the competitionvenue on 21.1.13 on their own. Transport from station/ airport/ bus-stand would not be provided by the organizers.
- All participants are to report at the competition at least one hour before the start of competition for completing the registration formalities.
- All drawing materials and associated requirements would be provided by CGWB. Items may include a kit containing paints, ruler, brushes, pencils, erasers, etc.
- 10. Drawing sheets for the painting will be provided by the organisers. The drawing sheets would be of 380 mm x 510 mm size (approx. 15" x 20").
- 11. Students are allowed to use their own painting materials if preferred.
- All students are required to bring identity proof or letter from respective school principal.
- 13. Selection of the prize winners and consolation prize winners are to be completed on the same day by juries and winners awarded.
- 14. Winners to be awarded certificate of merit.
- 15.All National level participants will be given certificate for the National level competition.
- 16. Arrangements for lunch, tea etc., would be made for the day of the competition by the organisers.
- 17. The painting competition would commence at 10.30 hours and would be for two hours duration. The competition would end at 12.30 hours. Results of the competition would be declared at 1600 hours. All participating students and their accompanying parents/guardians shall remain at the venue till the entire event is over.
