ORDER

The Exalt Integral Solutions Pvt. Ltd., a company providing innovative software solutions, has submitted a proposal vide letter read as 1st paper above before Government requesting to grant permission to all schools in the State including CBSE/ICSE/SSLC and all other professional schools to introduce 'Suraksh@School' a student tracking and vehicle tracking project developed by the company.

2) The project has been installed and implemented in Carmel Girls Higher Secondary School, Vazhuthacadu, Thiruvananthapuram on a pilot basis and it is reported that the system helped the institution to ensure the safety, security and monitoring of the children at school. The Director, Carmel Girls Higher Secondary School, Thiruvananthapuram vide his letter read as 3rd paper above recommended Suraksha@School as an important project which should be made mandatory for all the schools and students in the state of Kerala.

3) Government have examined the proposals. In view of the successful trial run conducted in Carmel Girls Higher Secondary School, Thiruvananthapuram, sanction is accorded for the implementation of Suraksha@School project in the state. The Suraksha@ School project personnel shall approach the school authorities for implementing the project and an amount of Rs.250/- can be realized from each willing student using school bus only one time for an academic year, being the cost of devices issued to them. The cost of devices to be installed in the institutions and school vehicles will be fixed through mutual understanding between the school Headmaster/Principal and the implementing agency. The company has also offered an insurance coverage of Rs. 1 lakh for every student covered in the project.

4) The Headmasters/Principals may evaluate whether the system proposed is beneficial to the school conditions and then take an appropriate decision with the concurrence of PTA/School Monitoring Committee.


