## ORDER No. H4/42406/2010/DPI DATED: 12.11.2012

Government as per order read as 2<sup>nd</sup> paper above have accorded sanction for pooling of the 1550 Specialist Teachers working in Government Schools and 134 Specialist Teachers who are working against non sanctioned posts and included in the teachers Package (at present posted as Cluster Co-ordinators) are positioned under SSA for pooling as Specialist Teachers in such a manner that the service of all teachers under Craft, Physical Education and Art will be made available to all Government U.P. Schools.

In the above circumstances, the 1550 Specialist teachers working in Government Schools and 134 Specialist Teachers posted as Cluster Co-ordinators are pooled under SSAUnder Right To Educational Act. Their service will be made available to U.P. Sections as well.

The following are the guidelines for "Pooling" arrangement of Teachers.

- 1. The Specialist Teachers working in Government Schools deemed to be positioned under SSA without change in their parent posting in Government School.
- 2. The Deputy Director of Education will ensure that there will be no dislocation caused to the teachers due to the positioning in SSA ordered in Government order dated 4.10.2012.
- 3. The Educational Officers will make suitable arrangement for the pooling of Specialist Teachers in the neighborhood schools where the teacher is now working so.
- 4. The Educational Officers will make sure that each teacher is provided with sufficient teaching hours as applicable to the full-time teacher.
  - 5. The Pooling shall be completed with immediate effect.

6. The Aided School Teachers working without sanctioned posts and now positioned in the SSA will be relieved of from the post of CRC Coordinator and retained as Part-Time Instructors provided in the schedule of the Right To Education Act-2009. They will be Pooled in 2 or more schools by the respective Deputy Directors of Education strictly in tune with guidelines issued as per letter read as 3<sup>rd</sup> paper above and after obtaining choice of schools from the teacher.
