## ORDER No. IED/48622/12/DPI Dated 21/12/2012

Under the scheme IEDSS, there is a provision for the purchase of equipments to resource centres and rooms for the year 2012-13. As such, an amount of Rs.70,000/- each at 5 educational district resource centres and Rs.55,000/- each at 42 resource rooms at school level will be utilized for the purchase of equipments to Resource Rooms/Centres set up in general schools, for improving the access to the class rooms and quality of their education. The fund is sanctioned to those schools where the resource centres and rooms are already set up during previous years.

Hence sanction is hereby accorded to utilize an amount of Rs.26,60,000/- (Rupees Twenty six lakh sixty thousand only) to purchase equipments to the resource room/centre set up in schools from the suggestive list enclosed, prepared by the administrative cell of IED, DPI office. Purchase should be made at school level by a team consisting of the Head Master, PTA President and Resource Teacher, as per the existing purchase rules. If Resource Teacher is not appointed in the school, Deputy HM or Senior Assistant should be included. The expenditure will be debited to the Head of Account 2235–02–101–95–34-OC (Plan).

Senior Finance Officer of Directorate is requested to place an amount of Rs.26,60,000/- (Rupees Twenty six lakh sixty thousand only) to the Deputy Directors of Education concerned as per the break-up given below under the Head of Account 2235–02–101–95–34-OC (Plan), for re-distribution to the District Education Officers concerned. The District Educational Officers concerned will draw and disburse the fund to the Schools by way of demand draft in favour of the Head Masters concerned with proper receipt and furnish the utilization certificate to this Office on or before 31/12/2012. All vouchers, bills and other relevant documents should be kept in the office of the school and the same should be submitted for proper audit as per existing rules.
