Order No. IED/31261/12/DPI Dated 21/12/2012

Under the scheme IEDSS, there is a provision for providing therapeutic services to children with special needs (CWSN) studying in general schools. Support can be made at cluster level and the needs of children with disabilities in a cluster of schools can be addressed. Since 2009-10, 22 speech therapy units and 38 physio therapy units have been sanctioned in general schools. These units are started attached to the resource room/centre already allotted to the school. Out of these therapy units, 19 speech therapy and 34 physiotherapy units are functioning and therapists are working as per the guidelines issued from this Directorate.

Remuneration to the Therapists has been fixed @ Rs.150/- per hour to a maximum of 50 hours per month. Minimum 3 hours therapy service should be given to each student in every week.

Fund is to be sanctioned to the following schools to meet the expenditure for disbursing the remuneration to the Speech Therapist/ Physio Therapist posted. Additional fund can be released if necessary, after reviewing the fund availability at a later stage.
