

PROCEEDINGS OF THE DIRECTOR OF PUBLIC INSTRUCTION, THIRUVANANTHAPURAM

Sub: IEDSS-2012-13 - Financial Assistance to Children with Special Needs (CWSN) in classes IX to XII (including VHSE) – Administrative Sanction accorded – Order issued – Reg.

Read: Proposal-IEDSS – 2012-13

ORDER NO.IED/91371/12/DPI dated 27/2/2013

Under the scheme of IEDSS for the year 2012-13, there is a provision for financial assistance to children with special needs studying in classes IX to XII. As such DEOs, Regional Deputy Directors (HSE) and Assistance Directors (VHSE) have submitted list of students in the prescribed proforma for financial assistance for the year 2012-13.

On the basis of the requirement submitted by above-said offices, **Rs.9,52,63,866/-** (Rupees Nine crore fifty two lakh sixty three thousand eight hundred and sixty six only) is calculated as the fund required for providing financial assistance to CWSN from IX to XII and VHSE. Fund is provided as follows:

For Book & Stationery, Uniform and Transport allowances @Rs.700/- each per year per student

State scholarship @Rs.600/- per year per student.

Escort allowance @Rs.850/- per year and Reader Allowance @Rs.750/- per year to eligible students

Girl stipend @Rs.2000/- per year to girl students in Std. IX and X

Hence sanction is hereby accorded for the release of **Rs.9,52,63,866/-** (Rupees Nine crore fifty two lakh sixty three thousand eight hundred and sixty six only) for the disbursement of financial assistance to CWSN from IX to XII and VHSE for the year 2012-13, which is to be debited to the Head of Account 2235-02-101-95-34-0C(Plan).

Senior Finance Officer of this Directorate is requested to place an amount of Rs.9,52,63,866/- (Rupees Nine crore fifty two lakh sixty three thousand eight hundred and sixty six only) under the Head of Account 2235-02-101-95-34-0C (Plan) to the Deputy Directors of Education, Regional Deputy Directors (HSE) and Assistant Directors (VHSE) as per the break-up given below.

Deputy Directors may re-allot the amount to the DEOs as per the break-up given above within 3 days of the receipt of the allotment. District Educational Officers may in turn draw the fund and disburse the amount to the beneficiaries (students) through the bank account opened for the purpose, without any delay. If the student is still reluctant to open a zero balance joint bank account, fund may be released through cheque issued in the name of the beneficiary.

The Regional Deputy Directors (HSE) and Assistant Directors (VHSE) may draw the fund from treasury and disburse the amount urgently to the beneficiaries (students) through the bank account opened for the purpose. If the student is still reluctant to open a zero balance joint bank account, fund may be released through cheque issued in the name of the beneficiary.

The DEOs, RDDs(HSE) and ADs(VHSE) should submit the utilization certificate in KFC-44 along with expenditure statement to the Director of Public Instruction, on or before 08/03/2013. It is the responsibility of the concerned DDEs, RDDs(HSE) and ADs(VHSE) to monitor the utilization of funds and to obtain and furnish the utilization certificate with expenditure statement, within the stipulated time limit. The concerned Officers will be personally responsible if the fund is not disbursed to the student in time or the fund gets lapsed.
