NOTIFICATION

G. O. (P) No. 186/2009/Gl.Edn. Dated, Thiruvananthapuram, 17th September, 2009.

S. R. O. No. 810/09.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following Rules to amend the Kerala Vocational Higher Secondary Education Subordinate Service Rules, 2004, issued under G. O. (P) No. 81/2004/Gl.Edn. dated 12th March, 2004 and published as S. R. O. No. 247/2004 in the Kerala Gazette Extraordinary No. 651 dated the 12th March, 2004, namely:—

RULES

1. *Short title and commencement.*—(1) These Rules may be called the Kerala Vocational Higher Secondary Education Subordinate Service (Amendment) Rules, 2009.

(2) They shall come into force at once.

2. *Amendment of the rules.*—In the Kerala Vocational Higher Secondary Education Subordinate Service Rules, 2004,—

(1) In rule 2,—

(i) in the Explanation under Category 1, for the word “hours” the word “period” shall be substituted;

(ii) in item 7 under Category 2, the brackets and the words “(Pre-Press Operation)” shall be omitted;

(iii) item 8 under category 2 shall be omitted;

(iv) for Category 3, the following shall be substituted, namely:—

“Category 3. Laboratory Technical Assistant in,—

- (1) Civil Construction and Maintenance;
- (2) Maintenance and Repairs of Two Wheelers and Three Wheelers;
- (3) Maintenance and Repairs of Automobiles;
- (4) Maintenance and Repairs of Radio and Television;
- (5) Maintenance and Repairs of Domestic Appliances;
- (6) Refrigeration and Air Conditioning;
- (7) Printing Technology;
- (8) Rubber Technology;

- (32) Office Secretaryship,
- (33) Accountancy and Auditing;
- (34) General Insurance;
- (35) Marketing and Salesmanship;
- (36) Reception, Book-Keeping and Communication;
- (37) Banking Assistance;
- (38) Catering and Restaurant Management;
- (39) Physiotherapy;
- (40) Mechanical Servicing (Agro Machinery);
- (41) Maintenance and Operation of Marine Engines;
- (42) Dental Technology".

(2) In the table under rule 3, against Serial No. 3 for the entries in column (2) and against item (i) in column (4), the following entries shall be substituted, namely:—

"Laboratory Technical Assistant (i) By transfer from qualified staff in the Ministerial Subordinate Service or Last Grade Service in the Department".

(3) In the TABLE under rule 4,—

(i) in Serial No.1,—

(a) against category (10) in item (i) in column (4), after the words "Commerce or Business Economics", the words, "or Economics" shall be inserted;

(b) in column (4), after the existing entries in item (i), the following entries shall be added, namely:—

“OR

B. Sc. Co-operation and Banking (four year course) with not less than 60% marks awarded by the Kerala Agricultural University or equivalent”.

(ii) in Serial No. 2,—

(a) against category 4, in the entry in column (4) after the words “Three year Diploma in Electronics”, occurring in the first paragraph, the words “or Electrical and Electronics” shall be omitted.

(b) against category 5 in column (4) after the words “ Three year Diploma in Electrical”, the words “and Electronics” and the symbol and word “/Electronics” after the word “Engineering”, shall be omitted.

(iii) in Sl. No. 2,—

(a) against the entries in category 7, in column (2), the brackets and the words “(Pre-Press Operation)” shall be omitted;

(b) Category (8) shall be omitted.

(c) against category (12), in column (4), in the first qualification, after the words “Mathematics” the symbol and word “/Chemistry” shall be inserted.

(d) against Category (13), in the first qualification in column (4) after the word “Mathematics” the symbol and word “/Chemistry” shall be inserted.

(e) against Categories (14), (15), (16) and (17), in column (4), the first qualification and the word “OR” occurring thereafter shall be omitted.

(f) against category (27), in column (4), the words “and a pass in Vocational Higher Secondary Education in Domestic Nursing conducted by Government of Kerala” occurring in the second paragraph, shall be omitted.

(g) against Category (30), in column (4),—

(i) in item (i), the words “or its equivalent” after the words “conducted by Government of Kerala” shall be omitted;

(ii) for the entries against item (ii), the following entries shall be substituted, namely:—

“In the absence of candidates with the qualification given in item (i),

1. B. Sc. Degree in Home Science awarded with not less than 50% marks from any of the University in Kerala or equivalent; and

2. One year certificate course in Cosmetology and Beauty Parlour Management from an institute recognized by Government or any University in Kerala."

(h) against category (32), in column (4), after the existing entries, the following entries shall be added, namely:—

"OR

B. Com. in Tourism and Travel Management from any of the Universities in Kerala or equivalent".

(iv) against Serial No. 3 for the entries in column (2), (3) and (4) the following entries shall be substituted, namely:—

"Laboratory Technical Assistant in

- (1) Civil Construction and Maintenance;

- (2) Maintenance and Repairs of Two Wheelers and Three Wheelers;

(v) in Note 1, under Serial No. 3 to the TABLE in rule 4, the words “or recognized as equivalent there to by anyone of the Universities in Kerala” Shall be added at the end.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have decided to amend the Kerala Vocational Higher Secondary Education Subordinate Service Rules, 2004, issued under G. O. (P) No. 81/2004/GE dated 12th march, 2004 and published as S. R. O. No. 247/2004 in the Kerala Gazette Extraordinary No. 651 dated the 12th March, 2004 so as to modify certain provisions as per the suggestion made by Curriculum Committee of Vocational Higher Secondary Education.

This notification is intended to achieve the above object.
