Sub: Clarification on Joining Time in the case of those who got appointment on or after 01/04/2013 but eligible for mobility to retain in Part III Pension scheme-reg

As per GO read as 1st above Government have implemented National Pension System to all employees who were appointed on or after 01/04/2013. As per G.O read 2nd and 3rd above Government allowed mobility to retain in Part III KSR Pension scheme in the case of Government Servants/employees of Autonomous Body /Aided Institution /PSU /Board etc who were appointed in substantive vacancies on regular basis on or before 31.03.2013 and who were in such posts on 31.03.2013 and to whom KSR Part III Pension Scheme is applicable in their respective institutions.

Several requests are being received seeking clarification regarding the time limit allowed for joining the institutions for allowing mobility to retain in Part III Pension Scheme. Government have examined the matter and are pleased to clarify that in the case of all those who come under the purview of above mentioned Government Orders admissible time limit is "6 days preparation time + actual journey time". The appointing authority shall issue the orders in eligible cases after verification of the prior service of the incumbent with respect to the conditions of this circular.
