Abstract

Kerala Service Rules-Maternity Leave to female officers who join a new station on transfer before expiry of the sanctioned leave-Eligibility-Orders issued.

ORDER

As per Note 6 below Rule 100, Part I, KSRs, female officers on Maternity Leave who get appointment in another Department or in the same Department by direct recruitment or by transfer or by promotion shall be allowed to avail the balance portion of Maternity Leave from the next day of joining duty in the new post or department subject to certain conditions specified therein. But this benefit has not been extended to those officers who are transferred from one station to another within the same department while on Maternity Leave.

2 .Several requests have been received to allow the balance portion of Maternity Leave to those officers who join duty in a new station, on transfer, while on Maternity Leave.

3. Government have examined the matter in detail and are pleased to extend the benefit of Note 6 below Rule 100, Part I, KSRs to those female officers who join the new station, on transfer, while on Maternity leave.

4. This order will take immediate effect.

5. Necessary amendments to Kerala Service Rules will be issued separately.


